



# Stories of Impact

#### TRENDING CAUSE: Youth Ministry

In Q3, The Signatry community recommended 397 grants to youth ministry organizations, including 28 grants to Freedom Fire Ministries. An organization that works with youth in the urban core of Kansas City, Freedom Fire seeks to equip youth with skills and knowledge that will enable them to make a positive impact in their community.

#### TRENDING CAUSE: Global Missions

The Signatry community recommended 1,361 grants to nonprofits working to share the gospel globally in Q3, including 21 grants for Ethnos360. Based in Sanford, FL, Ethnos360 mobilizes, equips, and coordinates Christians to evangelize unreached people groups, translate scripture, and see indigenous churches established that glorify God.





### TRENDING CAUSE: Poverty Alleviation & Sustainability

In Q3, The Signatry community recommended 393 grants to nonprofits tackling issues around poverty alleviation and sustainability, including 9 grants for Illinois-based One Collective. One Collective works in communities from Chicago to Nepal to bring people together around the ways of Jesus to create lasting change in our world today.





# Pragmatic Giving for Greater Impact

"I'm kind of a pragmatic thinker. What's the biggest impact we can have?"

This is how Taylor and Gayle Clark decide how to give. It has led them to champion student ministry, especially on college campuses. For the Clarks, supporting student ministry is both strategic and personal.

"I came to a personal relationship with Christ in college," Gayle said. "It changed everything."

Knowing the power of discipleship firsthand, the Clarks also value student ministry because of how pivotal the college years are. Taylor explained: "If you can change lives that have a lifelong trajectory [ahead] to live for kingdom purposes ... that's a 60, 70, or 80-year path."

Pragmatism in how they give is just as important to the Clarks.

Nonliquid giving through The Signatry is one critical strategy they use to multiply the value of their donations. Taylor donates long-term capital gains directly to a donor advised fund so that the full, pre-tax value of the asset can be used to support campus ministries.

He shared: "The donor advised fund is the best vehicle to allow us to donate assets prior to a sale, sell those assets, and [when] the full amount goes to the DAF, that allows us to give 20-23% more. It's whatever you avoid in taxes."

Through the DAF, those tax savings are transformed into real impact on college campuses.
